RELEASE AND WAIVER OF LIABILITY FORM

- 1. I confirm and declare that I am above 18 (eighteen) years of age and under no legal impediment to give this release and waiver.
- 2. - 3. I hereby declare and confirm that our participation is completely voluntary, in sound mind and with our full consent.
- 4. I and any member of my family or any person on behalf of whom I am signing this waiver hereby voluntarily assumes the risk of any injury to property and person during all activities at the event and release and forever discharge and hold harmless the organizers and owners of The Krazy Kids Karnival, event participants and their respective agents, officers, members and employees from any liability or claims that I may have with respect to personal injury, illness, permanent disability, death or property damage to me and/or any member of family or any person on behalf of whom I am signing this waiver, that may result as a result of participation in the Activities and use of any equipment/structures. The use of the facilities/ services is at our own risk.
- 5. We understand and agree that the event which we participate in presents certain unforeseen risks and dangers including, but not limited to, acts of God, the hazards of enjoying the amusement rides, games and that our participation entails known and unanticipated risks that could result in physical injury, paralysis, death, or damage to myself, to property, or to third parties irrespective of being warned and acquainted about the same.

We confirm that the organizers and its affiliates will not be liable for any losses, damages, claims of any kind arising in relation to the use or consumption of food served or products offered as gifts/manufactured by third parties. The organizers assume no responsibility for examining or evaluating the products and services offered and neither warrants that the services, food or Activities are of a merchantable quality whether express or implied.
- 7. We agree and confirm that we shall adhere to the safety norms for all the rides and attractions, age restrictions in terms of height and medical conditions and understand that the organizers shall have a right to restrict and refuse the participation in the Activities, reserve the right to restrict to offer services including food and beverages if the presence of the guest may pose a risk to himself or to the safety of other guests and/or affect the enjoyment of others.

- 8. By participating in this event, we agree that the organizers may click photographs, videos, reels, collect a variety of information from us, such as our name, email address and contact preferences, including any other usage and interaction details from us and the organizers shall have a right to use the above collected data as it deems fit.
- 9. We understand and agree that the organizers reserve the right to require us or any person already admitted to leave the venue, restrict from participating in any Activity, without refund or compensation for failure to comply with any of the rules, for unsafe, illegal or offensive behavior and to ensure safety, security and order, or the organizers consider that the circumstances so require.

We agree that the organizers reserve the right to hold liable, us or any guest who has caused any damage to, loss of, disappearance of, theft of, or any other form of alteration, physical or otherwise to the property if such event is caused by us or any guest due to gross negligence or non-compliance of the rules and regulations as set forth in this document.
- 11. We agree that the organizers reserve the right to close any ride / attraction and services, change the prices of the tickets, timings of the event etc. without any prior notice without any liability.
- 12. I hereby release, waive and forever discharge the organizers and owners of the event from any claim whatsoever which arises or may hereafter arise on account of first aid, treatment, or service rendered in connection with my participation in any of the Activities.
